Waitlist: There is waitlists for Saturday. The deadline for a Saturday withdrawal is Thursday March 30 or until no runs remain on the waitlist.

Check-in: Exhibitors who indicated no need for measurements and have no other special check-in requirements should simply check in on the ringside gate sheets. Refunds *might* be available at the trial, but if not they will be mailed (check with scoring if you are due a refund).

Measuring: We don't currently expect that there will be a VMO; but "Judge of Record measuring" has been resumed, so if you checked "my dog needs to be measured", please have the judge measure you before you run... actually, we don't care how tall you are, please have your dog measured instead! Be sure to arrive early enough to allow plenty of time/opportunities to get this done!

- THERE IS NO REASON FOR CONFLICTS with only one ring so please be on-time at ringside for your runs! (or be prepared to sacrifice your kneecaps...)

From I-270 near the airport, take Exit 39 (OH-16/E Broad St) Eastbound; turn North (left) onto Taylor Station Rd for 1.7mi; then turn right (East) onto Taylor Rd for 0.8mi; then turn right (South) onto Eastgate Pkwy. ARF will be on your right.

If for some reason your GPS cannot recognize the above address or mis-directs you, try: Buckeye Landscape Service 6608 Taylor Rd, Blacklick, OH which should get you to the corner of Taylor Rd and Eastgate Parkway
