Move-ups are due by **6pm on Monday, January 8<sup>th</sup>**.

Below you'll find judging assignments and the running schedule for the weekend. Please plan your arrival accordingly; also those of you who generously volunteered to work will receive a worker schedule (from Brenda Linscott - buckeye1661@yahoo.com) so that you can plan your weekend.

**Check-in:** Exhibitors who indicated no need for measurements and have no other special check-in requirements should simply check in on the ringside gate sheets. **No armbands will be issued!!** Refunds \*might\* be available at the trial, but most likely will be mailed.

**Measuring:** If you checked "my dog needs to be measured", please be prepared to have your dog measured **prior to running** - please allow some extra time to do this prior to the start of judging. We should have a VMO present all days - all dogs w/o a height card **MUST** be measured.

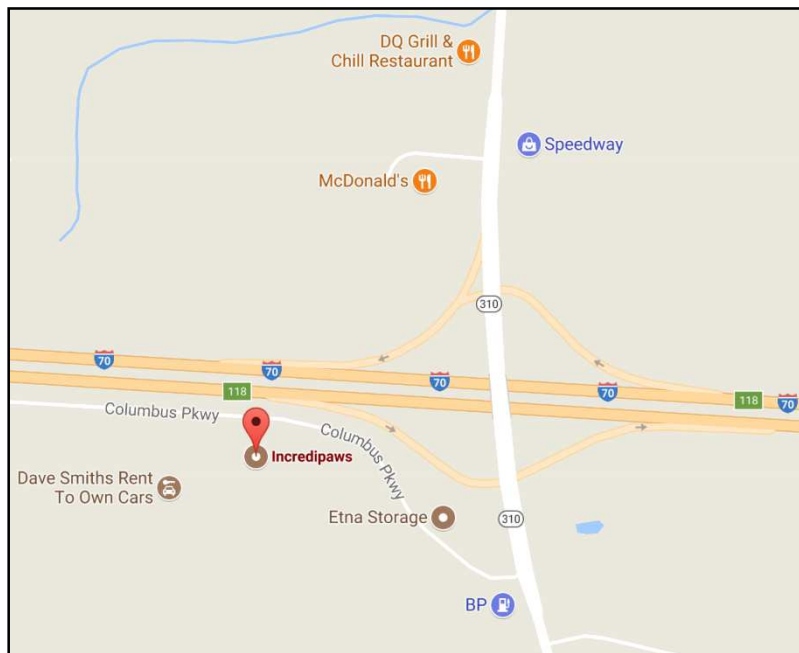

- **Mas/Exc-only entrants:** Please do not arrive earlier than needed! This is a full trial and space is limited - please help us provide a pleasant experience for the Novice/Open-only exhibitors!
- Running order: **24" C to 4"** all days
- STD & JWW: Novice B/A/P will run together by height in that order, as will Open/OpPref; Mas/MasP/Ex/ExP; and Prem/PremP
- Mas/Exc STD/JWW will be split into 4 walkthroughs: 24C/24/20 and 16/12/8/4 will each be split in half and will walk/walk-run/run. Premier, T2B and Nov/Open will not be split by height.
- **THERE IS NO REASON FOR CONFLICTS with only one ring** - so please be on-time at ringside for your runs! (or be prepared to sacrifice your kneecaps...)

### Show Site Info and Directions (Incredipaws Agility Training Center, 10465 Columbus Parkway, Pataskala, OH 43062):



**No Food will be available** at the show site. There are a variety of casual and fast food restaurants nearby.

**Overnight or RV parking is NOT permitted;** please contact Trial Chair if questions.

**Crating space is limited.** Please consolidate your area and limit chairs. X-pens must have at least two large dogs. Crates may be left overnight; however, neither CATC nor IncrediPAWS will be responsible for lost or damaged items left at the site.

**A limited number of front row parking spaces will be reserved for those willing to crate their dogs in the car.** Please contact Brenda Linscott (buckeye1661@yahoo.com) for more info.

**Please clean up after your dogs!** This show is being held at a private sports facility. Any exhibitor failing to do so may be excused without a refund if the Trial Committee determines there has been a violation. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

**From the East or West,** take I-70 to Exit 118 (OH-310/Pataskala); turn South onto SR-310; then turn right (West) onto Columbus Parkway. Travel West for 0.3mi; Incredipaws will be on your left (South).
