

CATC AKC AGILITY TRIAL SCHEDULE

JULY 21-22, 2018

Welcome to the Columbus All-breed Training Club agility trial... we hope you enjoy yourselves and that we see you again next year (check www.furrydogs.com for updates to this and future trials)! You'll find confirmations for your entries included in this mailing; please review them carefully and report any errors or missing information to the Secretary ASAP. Move-ups are due by **6pm on Monday, July 16th**.

Below you'll find judging assignments and the running schedule for the weekend. Please plan your arrival accordingly; also those of you who generously volunteered to work will receive a worker schedule (from Cindy Shipe at (614) 837-6559 or csbrimov@wowway.com) so that you can plan your weekend.

Moveups: Pretrial moveups are due in writing or by email no later than 6pm on Monday July 16th. Day-to-day moveups from Saturday's trial to Sunday must be received *at the trial* by the end of the trial on Saturday.

Check-in: Exhibitors who indicated no need for measurements and have no other special check-in requirements should simply check in on the ringside gate sheets. **No armbands will be issued!!** Refunds *might* be available at the trial, but most likely will be mailed.

Measuring: If you checked "my dog needs to be measured", please be prepared to have your dog measured **prior to running** - please allow some extra time to do this prior to the start of judging. We will have a VMO (AKC Rep) present all days - all dogs w/o a height card **MUST** be measured.

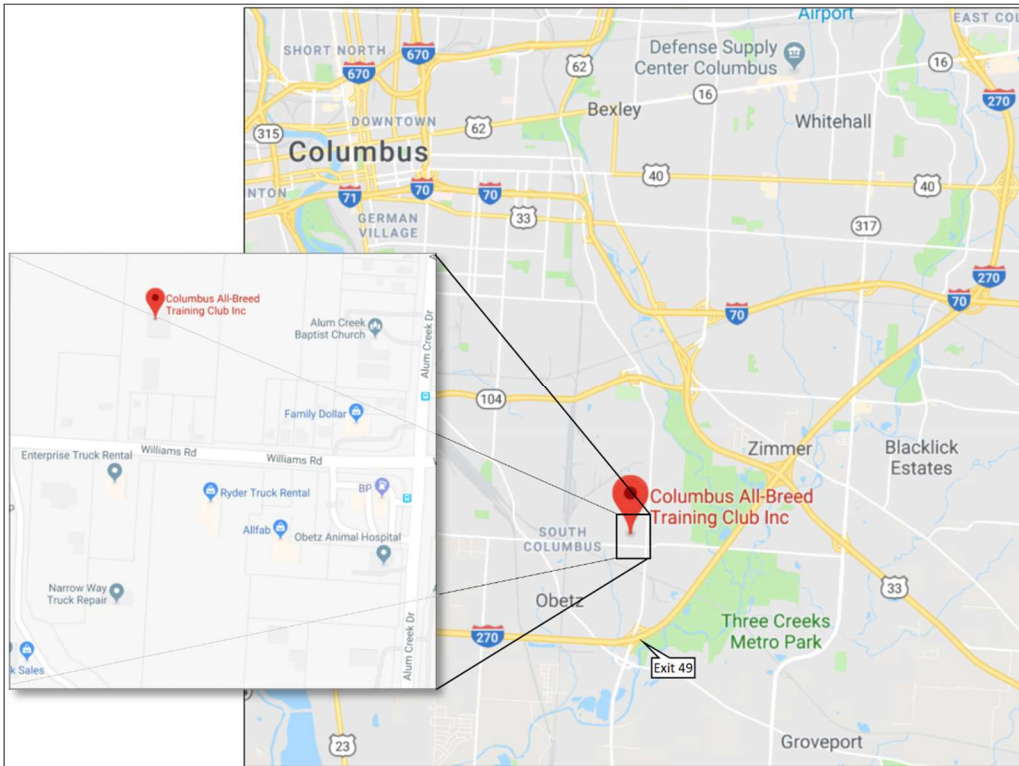
~ 9:00 Novice STD walk/briefing
→ 9:15 **Novice STD judging begins**
followed by Open STD walk & judging
followed by Op+Nov FAST walk & judging
followed by Novice JWW walk & judging
followed by Open JWW walk & judging

Sunday

~8:00 Open JWW walk/briefing
→ 8:15 **Open JWW judging begins**
followed by Novice JWW walk & judging
followed by T2B walk & judging
followed by Open STD walk & judging
followed by Novice STD walk & judging

- Running order: **4" to 24"C** all days
- STD & JWW: Novice B/A/P will run together by height in that order, as will Open/OpPref;
- Nov/Open walk throughs will not be split by height.
- **THERE IS NO REASON FOR CONFLICTS with only one ring** - so please be on-time at ringside for your runs! (or be prepared to sacrifice your kneecaps...)

Crating space is limited. A tarp or mat must be placed under all crates. No crating setup Friday night. Crating area will open at 7:00 AM on Saturday.

Please clean up after your dogs! Any exhibitor failing to do so may be excused without a refund if the Trial Committee determines there has been a violation. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Directions: From all directions, take I-270 to Exit 49 (Alum Creek Dr) on the South side of Columbus; turn North onto Alum Creek Dr to Williams Road (1.0mi); then turn left (West) onto Williams. Travel West for 0.2mi, and the CATC facility will be on your right (North)

Please clean up after your pets at the hotels! They are considered extensions of the show site, and we have requested these properties to notify us of any problems so that appropriate actions may be taken.
