You'll find confirmations for your entries included in this mailing; please review them carefully and report any errors or missing information to the Secretary ASAP. Note that move-ups are due by **6pm on Monday, December 27<sup>th</sup>**.

Below you'll find ring assignments and the running schedule for the weekend. Please plan your arrival accordingly (allow 5-10 minutes to get to the show site from I-70); also those of you who generously volunteered to work will receive a worker assignment schedule so that you can plan your weekend.

**Check-in:** Those exhibitors who indicated no need for measurements and have no other special check-in requirements will find their armbands at the check-in table. If you do not find your armbands at the table, please see the Trial Secretary (this will be true for anyone who indicated that one or more of their dogs need to be measured) or Registration attendant at the trial.

**Measuring:** If you did not check "my dog does not need to be measured", then please come to the check-in table or be prepared to have your dog measured **prior to running** - please plan to allow some extra time to do this prior to the start of judging. We will have a VMO present both days - all dogs w/o a height card **MUST** be measured.

### Ring 2 (JWW)

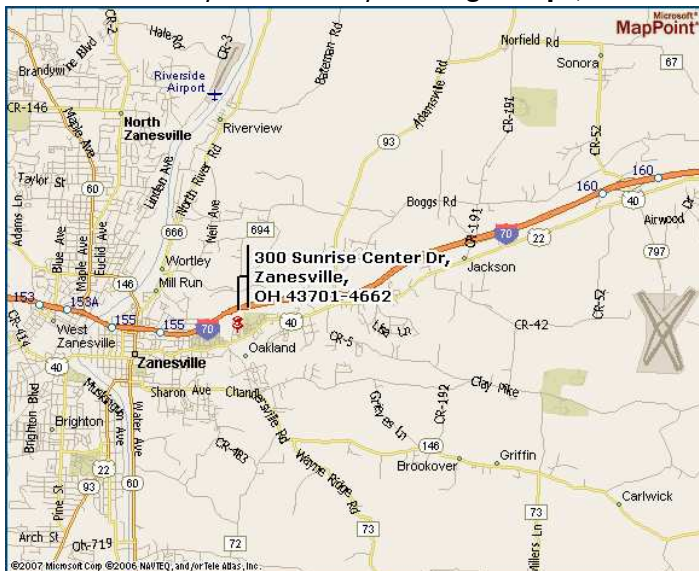
7:30 Open/OpP JWW walkthrough  
7:50 Open/OpP JWW briefing  
8:00 Open/OpP JWW judging begins  
followed by NovB/A/Pref JWW walkthrough & judging  
followed by Ex B/B Pref/A/A Pref JWW walk & judging  
followed by FAST Open walk & judging  
followed by FAST Novice walk & judging

- STD & JWW: Novice B, A, and Preferred will run together by height in that order, as will Open & Open Pref; and ExB, ExBP, ExA & ExAP.
- FAST: NovP, B, and A will run together by height, as will OpenP/Open, and ExBP/ExAP/ExB/ExA (Preferred dogs will run before Regular dogs at each height)
- Running order: 26" to 4" both days
- Excellent STD/JWW will be split into 5 walkthroughs (4-8, 12, 16, 20, & 24-26) minimum & may be further split. Nov/Open STD/JWW will not be split by height.

## Show Site Info / Directions / Crating Setup (Fieldhouse Family Sports & Wellness Center, 300 Sunrise Ctr, Zanesville OH 43701):



**Food and indoor restrooms will be available** at the show site.

**Overnight RV parking & camping at the show site is permitted;** please contact Trial Chairperson if questions. No dogs may be left unsupervised overnight at the show site, but crates/ex-pens/shelters may be left at the owner's risk. **There WILL be crating set up on Friday evening. The building will be open from 4-5pm Friday evening for set up - it will NOT be opened earlier since the Fieldhouse closes at 2pm that day!** There is plenty of crating space; however everyone is **REQUIRED** to place a waterproof tarp/mat underneath crates and chairs to protect the track surface. This will be strictly enforced!!

**Please clean up after your dogs!** This show is being held at a private sports facility. **No dogs are allowed in the restrooms!**

### Directions:

**From the East,** take I-70 to Exit 157; turn left (South) on SR-93 for 0.2mi; then turn right (West) onto US-22/US-40. Travel West for 1.1mi; Sunrise Center will be on your right (North).

**From the West,** take I-70 to Exit 155 for OH-60S/OH-146E. Bear left onto Elberon Ave; go 0.1mi, and turn right (South) onto OH-60S/146E. Travel 0.2mi and turn left (East) onto US-22/US-40. Travel East for 1.2mi; Sunrise

Center will be on your left (North).

**Hotel Info:** Many area hotels accept well-mannered dogs and handlers; some may charge additional fees for pets, so please call ahead to verify acceptance. Please clean up after your pets at the hotels! They are considered extensions of the show site, and we have requested these properties to notify us of any problems so that appropriate actions may be taken. The Exit 155 hotels are closest to the show site; Exit 160 hotels are a couple miles further (although only ~5 minutes farther). There are additional hotels ~20 minutes East and West of Zanesville (including a Red Roof). A list is available in the premium and on my website.
