Check-in: Exhibitors who indicated no need for measurements and have no other special check-in requirements should simply check in on the ringside gate sheets. **No armbands will be issued!!** Refunds *might* be available at the trial, but most likely will be mailed.

Measuring: If you checked "my dog needs to be measured", the judge *will* be able to perform official height card measurements – but due to COVID it is your choice whether to get a measurement or not. Please arrange a time that is convenient for both him and you...

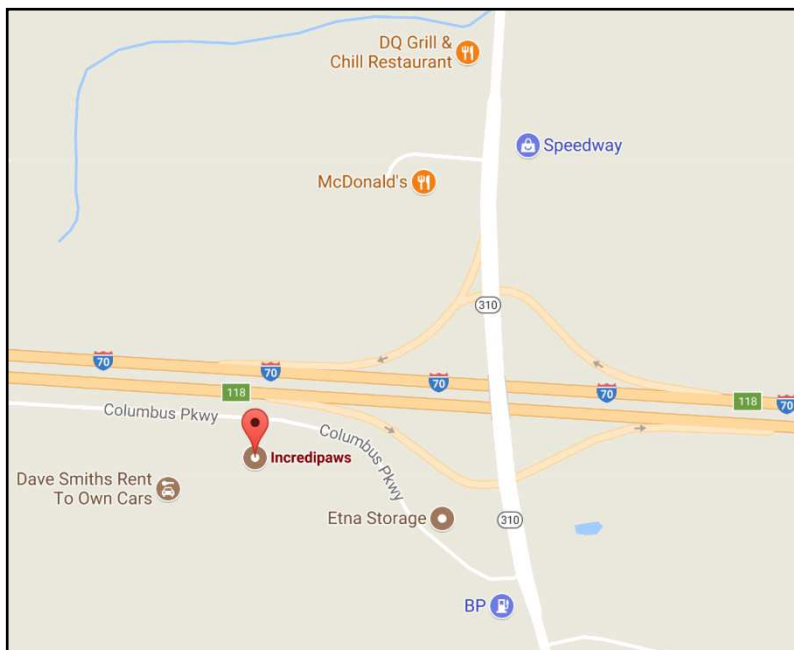

- Running order: **24" C to 4"** all days (possible exceptions for FAST or other classes with very few dogs in a level)
- **M/E STD/JWW walks:** Mas/Exc STD/JWW be split into at least 2 walk groups of 25 or fewer handlers each and we will then Walk-Walk-"Run all"
- **FAST:** ALL LEVELS will walk TOGETHER then run; but please check gate boards at the trial for details of how the levels will be run
- Walks for Premier, T2B and Nov/Open classes will **not** be split by height
- **THERE IS NO REASON FOR CONFLICTS with only one ring** – so please be on-time at ringside for your runs! (or be prepared to sacrifice your kneecaps...)



Show Site Info and Directions

(Incredipaws Agility Training Center, 10465 Columbus Parkway, Pataskala, OH 43062)

No Food will be available for general purchase at the show site; however **Workers/Volunteers will be provided bottled water and snacks**. There are a variety of casual and fast food restaurants nearby.

The building will be opened at 7am all days

Indoor crating space is limited and only reserved for workers upon request – please contact Dave (udx2@aol.com) or Brenda (buckeye1661@yahoo.com). If you are a worker and crating in the building, please park in the spaces furthest from the building so that exhibitors crating from their cars are closest to the building. Crates may be left overnight **only if you are entered the next day**; however, neither CATC nor Incredipaws will be responsible for lost or damaged items left at the site.

Overnight or RV parking is NOT permitted; please contact Trial Chair if questions.

Please clean up after your dogs! This show is being held at a private training facility. Any exhibitor failing to do so may be excused without a refund if the Trial Committee determines there has been a violation. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Directions:

From the East or West, take I-70 to Exit 118 (OH-310/Pataskala); turn South onto SR-310; then turn right (West) onto Columbus Parkway. Travel West for 0.3mi; Incredipaws will be on your left (South).

Hotel Info: Many area hotels accept well-mannered dogs and handlers; some may charge additional fees for pets, so please call ahead to verify acceptance. Please clean up after your pets at the hotels! They are considered extensions of the show site, and we have requested these properties to notify us of any problems so that appropriate actions may be taken.

IncrediPAWS Parking Restrictions

- ON FRIDAY + SATURDAY ONLY - No parking in the first 2 rows of the Spa Direct building, located immediately to the West.
- ON FRIDAY + SATURDAY ONLY - No parking in front of garage doors located on the West side of the building with the exception of the garage door belonging to IncrediPAWS.
- Parking is allowed in the area and the end of the gravel driveway. Cars may be parked in front of the storage units located South of Spa Direct/West of I-PAWS.
- Cars need to be within designated parking spots in the front lot so that semi trucks have access to the driveway.

Parking Rules (see map below)

- 1) Park in parking spots only
- 2) Do not part over lines
- 3) Do NOT park in the first two rows in front (North) of Spa Direct
- 4) Do not block garage doors
